Lots shall be used for single-family residence purposes only. The construction or creation of an accessory dwelling unit shall be prohibited.

This Section shall not prohibit residents from periodically hosting guests for short periods of time.

The Board of Directors is empowered to enforce the Declaration, the Articles of Incorporation, and the Bylaws by any remedy made available under the Virginia Code, including, but not limited to, the Property Owners Association Act, including Section 55.1-1819 herein attached as exhibit A. Prior to the exercise of any remedy, the Association shall provide the member with written notice and an opportunity to correct the violation or to request a hearing at which the member may be represented by counsel.

Assuming the foregoing amendment is enacted, a new Section 3 shall be added to Article V; or if the foregoing amendment is not enacted, a new Section 2 shall be added to Article V:

Owners may not use their garage for any purpose other than parking vehicles. A garage will be considered utilized for a purpose other than parking vehicles if, during any one twenty-four-hour period, the number of vehicles for which the garage is designed cannot be parked inside of it with the garage door closed. Residents must park their vehicle(s) in their garage, unless they possess a greater number of vehicles than the garage is designed to accommodate, in which case residents must first use driveway space to park additional vehicles before utilizing street parking. Vehicles shall not be parked on Common Driveways. The Board of Directors may enact rules or regulations, which are not inconsistent with the Declaration and Bylaws, regulating the parking of vehicles.
